

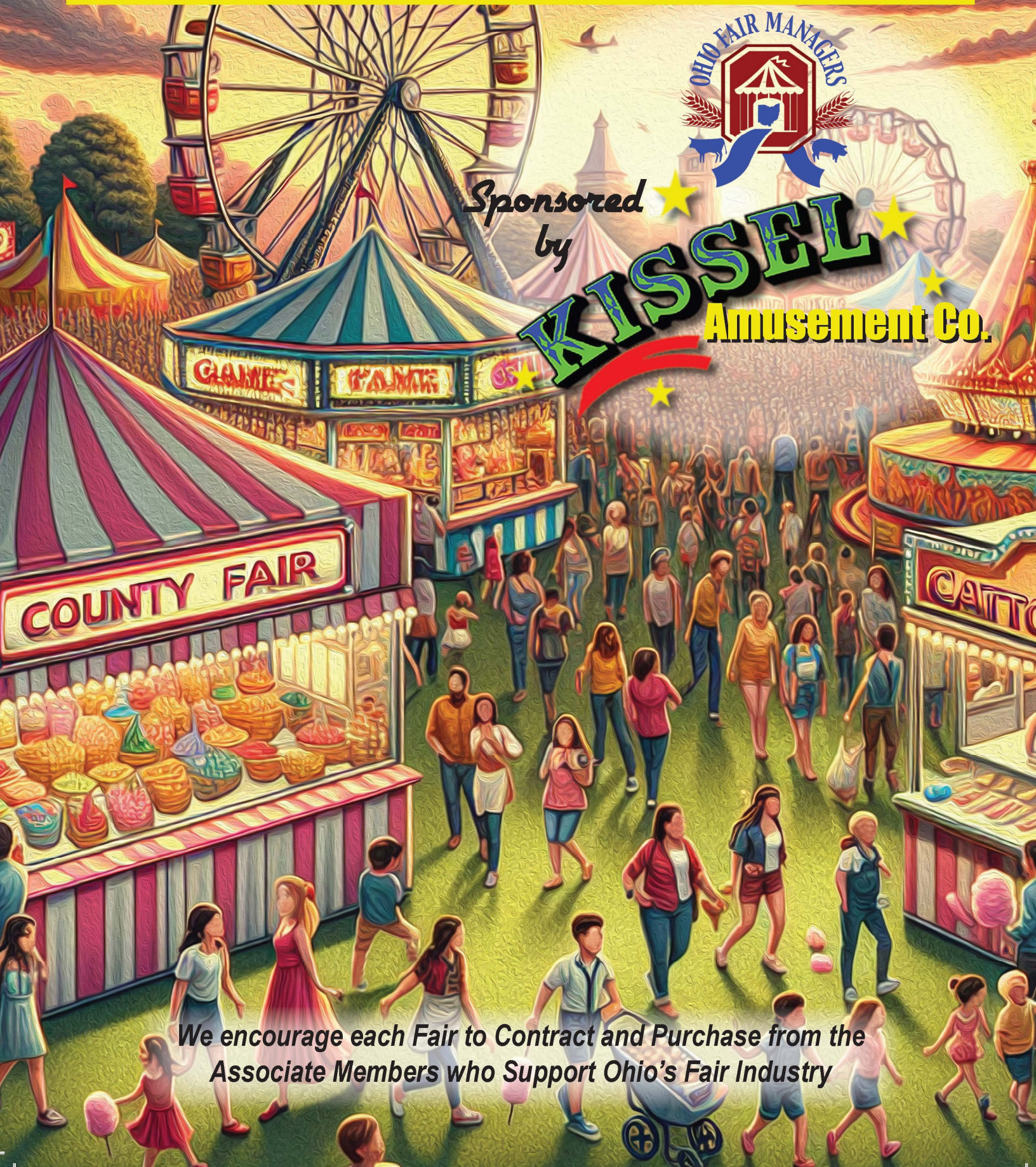

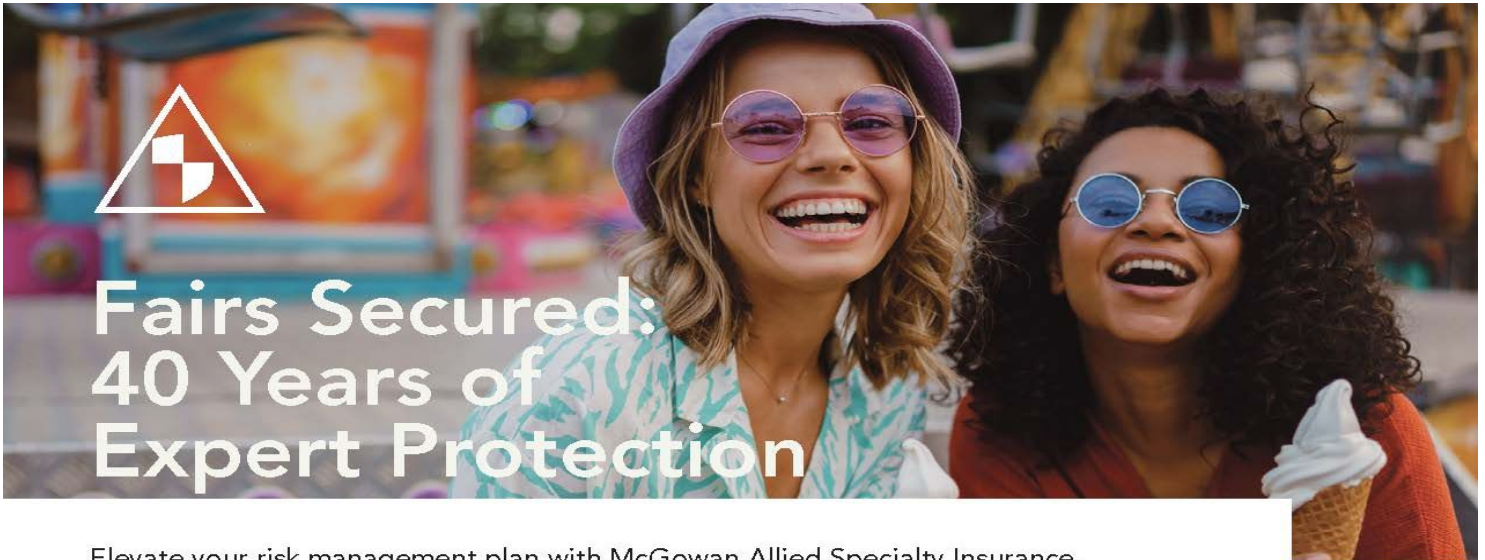

Dan has been a valued member of the Brown County Fair for 42 years. During that time, he served seven years as Vice President and contributed to numerous committees, including Grounds, Junior Fair, Demo Derby, Hogs, Poultry, Sheep, and many others. Wherever Danny was needed, he stepped in and served with exceptional dedication and commitment.

Danny Gray has spent his entire life in Brown County, residing in Byrd Township near Decatur, Ohio. His parents were farmers, and after graduating from Russellville High School in 1962, Danny purchased the family farm, which he continues to operate today. He especially enjoys working alongside his brothers, Dick and Tony, who assist with farming activities.

Danny has played a significant role in fairground improvements over the years. He strongly supported the purchase of adjoining farmland and the development of those properties. Danny chaired the Shuttle Bus Committee, which originally operated two shuttles. To improve the system, he visited the Ohio State Fair and other county fairs to study their shuttle operations. After reviewing these models, Danny worked with a local fabricator to design tractor-pulled shuttles capable of safely transporting fairgoers, strollers, and wagons throughout the fairgrounds parking lots.

Danny understands the importance of youth activities and their strong connection to promoting agriculture. He attended sessions at the Ohio Fair Mangers Convention for more than 38 years and brought back many valuable ideas to benefit the Brown County Fair. One idea he is especially proud of was the creation of a children’s play area featuring agricultural products and educational information. This interactive space allowed kids to have fun while learning and was extremely well received by fairgoers.

Danny has been involved in numerous projects and improvements at the fairgrounds. He served on the Grounds Committee for 33 years and has chaired the committee for the past 22 years. To say Danny has witnessed—and helped lead—many improvements at the fairgrounds would be an understatement.

When asked about his favorite project, Danny named the Beef Complex, built in 1997. At the time, additional space was needed to accommodate the growing number of cattle projects, provide indoor storage for equipment, and create an arena for showing cattle and other species. Although Danny was not the Grounds Committee chair at that time, he was asked to oversee the project. This included coordinating contractors, fair board members, volunteers, and the Brown County Cattlemen, who helped provide initial funding. Through teamwork and dedication, the project was a great success and continues to be enjoyed by exhibitors today.

Beyond his work with the Brown County Fair, Danny served in the Air Force Reserves Fire Department Crash and Rescue from 1966 to 1972. He was Chief of the Byrd Township Volunteer Fire Department from 1988 to 1998. Danny also served as an advisor for the Decatur Busy Workers 4-H Club from 1956 to 1966 and was a member of the Brown County Cattlemen’s Association for 31 years.

Kim R. Meyers has been an indispensable leader and tireless advocate for the Lorain County Fair and the Ohio Fairs Community. Over 21 years of involvement, including six years as a volunteer and 16 years as a Fair Board Director, Kim has demonstrated unwavering commitment, strategic vision, and a deep passion for public service.

Elected as a Director in 2005, Kim served as the Lorain County Fair's Midway & Concessions Chairman through 2025 and as Media Relations Chairman for 16 years, skillfully shaping the fair's public image and guiding communications with professionalism and integrity. His leadership on the Executive Board included four years as President, two years as Vice President, and three years as Immediate Past President.

During his presidency, Kim guided the fair through the unprecedented challenges of the COVID-19 pandemic, ensuring adaptability, resilience, and continued community engagement. He also played a critical leadership role during August 24, 2023, fair closure, when severe storms and torrential rain required difficult, real-time decisions to protect public safety. As a Director, Kim was instrumental in infrastructure modernization efforts, major capital projects, and the exposition center initiative.

The Ohio Fair Mangers is proud to announce the induction of Bert Dawson in support of the Columbiana County Fair Board into the 2026 Class of the Ohio Fair Mangers Hall of Fame

Bert Dawson's contributions to the **Columbiana County Fairgrounds** are particularly noteworthy.

For decades, Mr. Dawson has supported the Fair in ways both visible and behind the scenes. Whether providing manpower, equipment, materials, engineering expertise, or simply a willingness to help whenever needed, Mr. Dawson and his crews have been indispensable partners.

The Fairgrounds have benefited from his dedication in countless ways:

Covered Bridges: Columbiana County is home to five restored covered bridges, and one of these historic structures—though not originally an active bridge—was relocated to the Fairgrounds, where it has greeted fairgoers for many years.

The Chip and Seal Program: Each year, the County Highway Department performs this essential maintenance not just for townships and villages, but also for the Fairgrounds. Mr. Dawson donates materials, equipment, and manpower to improve and preserve our roads, enhancing both appearance and functionality for all who visit.

Property Surveys: As the Fair has expanded, acquiring new land for parking and campgrounds, Mr. Dawson personally oversaw surveys, descriptions, and deed work—saving time and money for the Fair and helping ensure each project's success.

The 2017 Bowstring Arch Bridge Project: This 1872 wrought iron bridge—one of the few remaining examples of its kind—was carefully rehabilitated and relocated to the Fairgrounds under Mr. Dawson's leadership. Today it stands as a focal point and a beloved landmark. The project was so well executed that it received the **Ohio Historic Bridge Preservation Award** in 2017.

Restroom Facilities: Understanding the Fair's need for ADA-compliant, modern restrooms, Mr. Dawson helped secure \$300,000 in State funding that led to the construction of today's much-improved facilities.

The Street Sign Project: The familiar street signs named after the County's townships—helping guide thousands of visitors—were produced by his highway department.

The 2014 Grandstand: During the planning and construction of one of the largest projects in Fair history, Mr. Dawson's crews provided essential assistance that helped make the new 2,500-seat, ADA-accessible grandstand a reality.

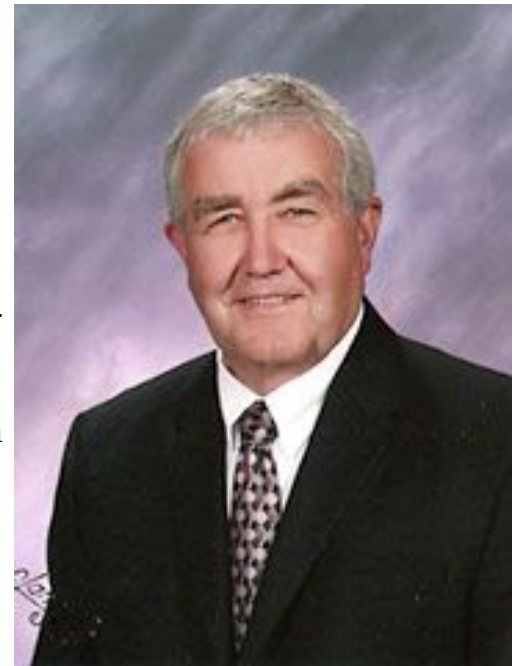
Bleacher Seating Improvements: Once again, he offered equipment and materials to support much-needed upgrades.

Beyond the Fairgrounds, Mr. Dawson's preservation efforts extend across the County. He spearheaded the restoration of the **P.L. & W. Train Station**, originally built in 1886, securing funding that transformed it into a resource for bikers, historians, and community groups.

He also rehabilitated all five historic wrought iron truss bridges spanning the scenic Little Beaver Creek—a testament to his commitment to preserving our architectural heritage.

Ladies and gentlemen, what we see in Mr. Dawson's career is not merely longevity—it is legacy.

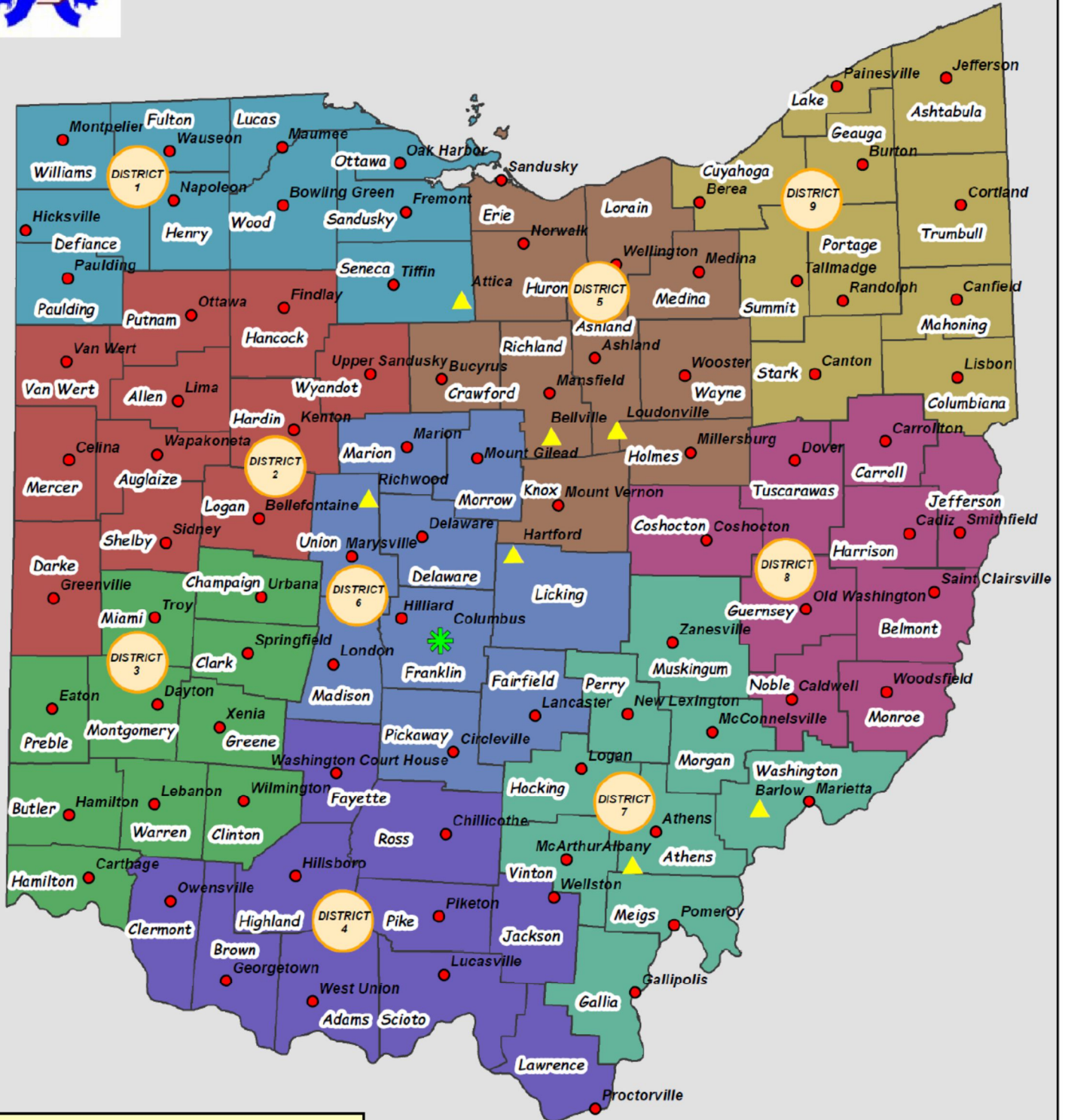
